Our cash position is satisfactory. We have made it through the year end "tight cash flow" situation. We disbursed \$13,791.10 from Sound Com Bank on Jan 3, 2022; leaving a cusion of \$2,645.25. That is a bit low for comfort, but the 2022 dues are already being deopsited.

The Kitsap accounts will be used for the new "Reserve Fund" in 2022. The budget calls for the reserve to receive \$3,430 per quarter. That leaves us with \$1,480 still to deposit by the end of the first quarter.
